**STAKEHOLDER INPUT:** The National Institute of Food and Agriculture (NIFA) seeks your comments about this RFA. We will consider the comments when we develop the next RFA for the program, if applicable, and we'll use them to meet the requirements of section 103(c)(2) of the Agricultural Research, Extension, and Education Reform Act of 1998 (7 U.S.C. 7613(c)(2)). **EXECUTIVE SUMMARY:** NIFA requests applications for the Renewable Resources Extension Act Program for fiscal year (FY) 2014. These grants are used to assist all states in carrying out a program of extension activities designed to (1) provide educational programs that enable individuals to recognize, analyze, and resolve problems dealing with renewable resources, including forest- and range-based outdoor recreation opportunities, trees, and forests in urban areas, and trees and shrubs in shelterbelts; (2) use educational programs to disseminate the results of research on renewable resources; (3) conduct educational programs that transfer the best available technology to those involved in the management and protection of forests and rangelands and the processing and use of their associated renewable resources; (4) develop and implement educational programs that give special attention to the educational needs of small, private non-industrial forest landowners; (5) develop and implement educational programs in range and fish and wildlife management; (6) assist in providing continuing education programs for professionally trained individuals in fish and wildlife, forest, range, and watershed management and related fields; (7) help forest and range landowners in securing technical and financial assistance to bring appropriate expertise to bear on their problems; and (8) help identify areas of needed research regarding renewable resources. The amount available for support of this program in FY 2014 is approximately \$3,597,600. Funds are to be distributed through grants to the institutions on a quarterly basis. The specific distributions are included in Appendix A of this

RFA. In FY 2014, subject to having met the previous year's reporting requirements, the first three quarterly payments will be combined and issued in April and the last quarterly payment is scheduled for release in July.

This notice identifies the objectives for RREA projects, the eligibility criteria for projects and applicants, and the application forms and associated instructions needed to apply for a RREA grant.

## **PART I—FUNDING OPPORTUNITY DESCRIPTION**

### **A. Legislative Authority and Background**

The Renewable Resources Extension Act (P. L. 95-306 (92 Stat. 349, 16 U.S.C. 1671 et seq.)) established the Renewable Resources Extension Act Program in 1978. This law provides the basis for Federal funding for extension activities associated with fish, wildlife, and water resources on private forest and rangelands and for renewable resource education programs at State Land-Grant Institutions established under the Morrill Act of July 2, 1862, as amended; the Hatch Act of March 2, 1887, as amended; the Morrill Act of August 30, 1890, as amended, including Tuskegee University; and other State-supported colleges and universities offering graduate training in the sciences basic to forestry and having a forestry school.

States are eligible for funds appropriated under this Act according to the respective capabilities of their private forests and rangelands for yielding renewable resources and relative needs for such resources identified in the periodic Renewable Resource Assessment provided for in Section 3 of the Forest and Rangeland Renewable Resources Planning Act of 1974 and the periodic appraisal of land and water resources provided for in Section 5 of the Soil and Water Resources Conservation Act of 1977.

Under the Federal Funding Accountability and Transparency Act (FFATA), the U.S. Office of Management and Budget (OMB) was required to develop and maintain a public searchable data base for all Federal financial assistance awards, and Federal agencies were required to report specific data elements which were collected via these applications (e.g., Dun and Bradstreet Data Universal Numbering (DUNS) numbers, legal name of institution, legal address, and congressional district). OMB makes this information available at <http://www.usaspending.gov>.

## **B. Purpose**

The purpose of this funding is to assist states in carrying out an extension program designed to assist forest and range landowners and managers in making resource management decisions based on research findings. Forest and rangeland resources include vegetation, water, fisheries and wildlife, soil, and recreation. A RREA Strategic Plan for FY 2012-2016 has been completed and the priorities listed in that plan are to be the focus of RREA expenditures by recipients.

## **PART II—AWARD INFORMATION**

### **A. Available Funding**

The amount available for support of this program in FY 2014 is approximately \$3,597,600.

Funds are to be distributed through grants to the institutions on a quarterly basis in FY 2014. In FY 2014, subject to having met the previous year's reporting requirements, the first three quarterly payments will be combined and issued in April and the last quarterly payment is scheduled for release in July.

Awards issued as a result of this RFA will have designated the Automated Standard Applications for Payment System (ASAP), operated by the Department of Treasury's Financial Management Service, as the payment system for funds. ### **B. Type of Application**

In FY 2014, submit applications to the RREA Program as a "new" application.

### **C. Responsible and Ethical Conduct of Research**

The Renewable Resources Extension Act funds may not be used for research activities. The funds are to be used exclusively for Extension programs.

## **PART III—ELIGIBILITY INFORMATION**

Award recipients may subcontract to organizations not eligible to apply provided such organizations are necessary for the conduct of the project.

### **B. Cost Sharing or Matching**

There is no cost-sharing or matching requirement for this program.

## **PART IV—APPLICATION AND SUBMISSION INFORMATION**

#### **D. Funding Restrictions**

##### **(1) Approved NIFA RREA Projects**

RREA Federal funding must be used on the strategic issues from the FY 2012-2016 RREA Strategic Plan identified in the institution's approved 5-Year Plan of Work for FY 2012-2016.

##### **(2) Matching**

There is no cost-sharing or matching requirement for this program.

##### **(3) Indirect Costs and Tuition Remission**

In accordance with section 1473 of the National Agricultural Research, Extension, and Teaching Policy Act of 1977 (7 U.S.C. §3319), indirect costs and tuition remission are unallowable as RREA formula grant expenditures.

## **PART V—APPLICATION REVIEW REQUIREMENTS**

### **A. General**

The Planning, Accountability, and Reporting Staff and the Office of Grants and Financial Management (OGFM) Capacity Grants Branch will be reviewing submitted documents to determine if all program, financial, and administrative requirements have been met and are current.

### **B. Organizational Management Information**

Specific management information relating to an applicant shall be submitted on a one time basis, with updates on an as needed basis. This requirement is part of the responsibility determination prior to the award of a grant identified under this RFA, if such information has not been provided previously under this or another NIFA program. We will provide you copies of forms recommended for use in fulfilling these requirements as part of the pre-award process. Although an applicant may be eligible based on its status as one of these entities, there are factors that may exclude an applicant from receiving federal financial and nonfinancial assistance and benefits under this program (e.g., debarment or suspension of an individual involved or a determination that an applicant is not responsible based on submitted organizational management information).

## **PART VI—AWARD ADMINISTRATION**

### **A. General**

All current program and administrative requirements must be met by the eligible institution before funding will be released. The OGFМ Capacity Grants Branch will notify the institutions when all requirements have been met or approved.

Within the limit of funds available for such purpose, the NIFA awarding official shall make grants to those responsible, eligible applicants. All funds granted by NIFA under this RFA may be used only for the purpose for which they are granted in accordance with the approved application and budget, regulations, terms and conditions of the award, applicable federal cost principles, USDA assistance regulations (parts 3015 and 3019 of 7 CFR).

### **B. Award Notice**

The award document will provide pertinent instructions and information including, at a minimum:

- (5) Project period, specifying the amount of time NIFA intends to support the project without requiring re-competition for funds;
- (6) Total amount of financial assistance approved for the award;
- (7) Legal authority(ies) under which the award is issued;
- (8) Appropriate Catalog of Federal Domestic Assistance (CFDA) number;
- (9) Applicable award terms and conditions (see <http://www.nifa.usda.gov/business/awards/awardterms.html> to view NIFA award terms and conditions);
- (10) Approved budget plan for categorizing allocable project funds to accomplish the stated purpose of the award; and

(11) Other information or provisions deemed necessary by NIFA to carry out its respective awarding activities or to accomplish the purpose of a particular award.

### **Requirement for Central Contractor Registration (CCR)**

Unless you are exempted from this requirement under 2 CFR 25.110, you as the recipient must maintain the currency of your information in the CCR until you submit the final financial report required under this award or receive the final payment, whichever is later. This requires that you review and update the information at least annually after the initial registration, and more frequently if required by changes in your information or another award term.

1. Must notify potential subrecipients that no entity (see definition in paragraph C of this award term) may receive a subaward from you unless the entity has provided its DUNS number to you.
2. May not make a subaward to an entity unless the entity has provided its DUNS number to you.

Definitions - For purposes of this award term:

### **Federal Agency Identification Number (FAIN)**

A FAIN is a unique number federal agencies assign to federal financial assistance awards. NIFA assigns a FAIN to each award and includes it in block 8. of the award document (NIFA-2009). Awardees must document the assigned FAIN on each subaward under the Federal award.

### **Assurance Regarding Felony Conviction or Tax Delinquent Status for Corporate Awardees**

Awards resulting from this RFA are subject to the provisions contained in the Consolidated and Further Continuing Appropriations Act, 2013, Pub. L. #### **1. Plan of Work (POW) Reporting**

The Plan of Work Update for FY 2015-2019 and Annual Report of Accomplishments and Results for FY 2013 were due by April 1, 2014 and should be submitted online through the NIFA Reporting Portal at the web address: <http://portal.nifa.usda.gov/portal>.

#### **2. Financial Reporting**

Financial reporting via the SF-425, Federal Financial Report for FY 2014 is due to the Capacity Grants Branch of OGF on April 1, 2015 for the period October 1, 2013 through September 30, 2014 and annually thereafter until the award is closed out. **RREA funds are expected to be fully expended in the fiscal year of appropriation; however current policy allows 50 percent of the prior fiscal year allocation to be carried over into the next fiscal year. These carryover funds must be fully expended by September 30 of the following year (e.g. September 30, 2015 for FY 2014 funds).** However, waiver requests may be considered and

approved. Requests should be submitted to the Program Managers listed in Part VII of this RFA, who will provide the required format for requesting carryover of excess (>50%) funds. Prior approval is required to carry over funds for one additional year; however, no additional carryover requests may be considered or approved, as no legislative authority to do so is provided.

### **3. REEport Reporting**

Details of annual and final technical reporting requirements also are included on the NIFA web site at [http://www.nifa.usda.gov/business/pp\\_formula\\_grants.html](http://www.nifa.usda.gov/business/pp_formula_grants.html). The following is a description of the CRIS reporting requirements.

Institutions must submit a Form AD-416, Work Unit Description; Form AD-417, Project Classification; NIFA-2008, Assurance Form; and Project Proposal through the Current Research Information System prior to the initiation of each Hatch project. The project must undergo a review process and be approved before it is incorporated into the Program of Research. Each institution shall submit a CRIS Form AD-421, Accomplishments Report, annually for each eligible project. Reports from institutions reporting on a calendar year shall be submitted by April 1, 2014 for the preceding calendar year. Reports from institutions reporting on a fiscal year shall be submitted by February 1, 2014 for the preceding fiscal year.

An Accomplishments Report, CRIS Form AD-421, shall be submitted to NIFA for each completed or terminated project. Such reports shall be submitted at the same time as are progress reports on active projects and should include a brief summary of accomplishments for the entire life of the project.

A CRIS Form AD-419, Funding and Staff Support Report, shall be submitted to NIFA annually for all projects. CRIS Form AD-419 reports are also required for expenditures on all State projects that are to be included in the non-Federal funds and matching funds computation. Reports shall be made on a fiscal year basis and are to be submitted by February 1, 2014.

### **4. Reporting Subawards and Executive Compensation**

**2. Where and when to report.** You must report executive total compensation described in paragraph b.1. of this award term:

i. As part of your registration profile at <https://www.sam.gov/sam/>.

ii. By the end of the month following the month in which this award is made, and annually thereafter.

**c. Reporting of Total Compensation of Subrecipient Executives**

**1. Applicability and what to report.** Unless you are exempt as provided in paragraph d. of this award term, for each first-tier subrecipient under this award, you shall report the names and total compensation of each of the subrecipient's five most highly compensated executives for the subrecipient's preceding completed fiscal year, if--

i. In the subrecipient's preceding fiscal year, the subrecipient received--

**2. Where and when to report.** You must report subrecipient executive total compensation described in paragraph c.1. of this award term:

i. To the recipient.

ii. By the end of the month following the month during which you make the subaward. For example, if a subaward is obligated on any date during the month of October of a given year (i.e., between October 1 and 31), you must report any required compensation information of the subrecipient by November 30 of that year.

d. Exemptions

- ii. The term does not include your procurement of property and services needed to carry out the project or program (for further explanation, see Sec. --- .210 of the attachment to OMB Circular A-133, "Audits of States, Local Governments, and Non-Profit Organizations").
- iii. A subaward may be provided through any legal agreement, including an agreement that you or a subrecipient considers a contract.

4. Subrecipient means an entity that:

- i. Receives a subaward from you (the recipient) under this award; and
- ii. Is accountable to you for the use of the Federal funds provided by the subaward.

5. Total compensation means the cash and noncash dollar value earned by the executive during the recipient's or subrecipient's preceding fiscal year and includes the following (for more information see 17 CFR 229.402(c)(2)):

- i. Salary and bonus.
- ii. Awards of stock, stock options, and stock appreciation rights. Use the dollar amount recognized for financial statement reporting purposes with respect to the fiscal year in accordance with the Statement of Financial Accounting Standards No. 123 (Revised 2004) (FAS 123R), Shared Based Payments.
- iii. Earnings for services under non-equity incentive plans. This does not include group life, health, hospitalization or medical reimbursement plans that do not discriminate in favor of executives, and are available generally to all salaried employees.
- iv. Change in pension value. This is the change in present value of defined benefit and actuarial pension plans.
- v. Above-market earnings on deferred compensation which is not tax-qualified.
- vi. Other compensation, if the aggregate value of all such other compensation (e.g. severance, termination payments, value of life insurance paid on behalf of the employee, perquisites or property) for the executive exceeds \$10,000.
