Comments regarding this request for applications (RFA) are requested within 6 months from the issuance of this notice. Comments received after that date will be considered to the extent practicable.

**STAKEHOLDER INPUT:** The National Institute of Food and Agriculture (NIFA) seeks your comments about this RFA. We will consider the comments when we develop the next RFA for the program, if applicable, and we'll use them to meet the requirements of section 103(c)(2) of the Agricultural Research, Extension, and Education Reform Act of 1998 (7 U.S.C. 7613(c)(2)). **EXECUTIVE SUMMARY:** NIFA requests applications for the **Preschool Access Feasibility Study (PAFS)** Competitive Grant Program for fiscal year (FY) 14 to design a feasibility study which will assess the preschool program availability to military families located **outside the continental United States** (OCONUS) installations worldwide. The amount available for support of this program in FY 2014 is approximately **\$315,000**.

This notice identifies the objectives for **PAFS** projects, the eligibility criteria for projects and applicants, and the application forms and associated instructions needed to apply for a **PAFS** grant.

## **PART I—FUNDING OPPORTUNITY DESCRIPTION**

### **A. Legislative Authority and Background**

In accordance with the Economy Act of 1932, as amended, (31 U.S.C. 1535), The Office of the Under Secretary of Defense for Military Community and Family Policy (OUSD {MC&FP}), in order to utilize the unique resources of USDA and its land-grant institution partners, has provided NIFA with funds to support the PAFS.

Pursuant to 7 U.S.C. Sec. 3318(c), the Secretary of Agriculture, acting through the Director of the NIFA, may enter into contracts, grants, or cooperative agreements, for periods not to exceed five years, with State agricultural experiment stations, State cooperative extension services, all colleges and universities, other research or educational institution or organization, Federal and private agencies and organizations, individuals, and any other contractor or recipient, either foreign or domestic, to further research, extension, or teaching programs in the food and agricultural sciences of the Department of Agriculture.

This project supports the mission of the DoD-USDA Military Extension Partnership Memorandum of Understanding signed in 2010, which states, “This Memorandum of Understanding (MOU) sustains the interagency momentum developed through collaborations with the United States Department of Agriculture (USDA), land-grant universities, and the Cooperative Extension Service in providing joint programs in support of military children, youth, and families, and is responsive to General Accounting Office (GAO) recommendations by creating the Partnership for Military Families, to address future cross-cutting issues and challenges in supporting military families, particularly those who are geographically dispersed.”

### **B. Purpose and Priorities**

NIFA is seeking applications from institutions that can demonstrate their ability to assess the availability of preschool programs at OCONUS installations utilizing multiple sources of data, feedback, and information and synthesize findings in a final report that will inform future directions for planning preschool access among military families.

This project involves the following objectives:

- Identify and operationalize the research based, empirically proven elements of high-quality developmentally appropriate preschool programs to include curriculum, scheduling, staffing, and logistics through an extensive literature review.
- Summarize the current preschool programs available at each OCONUS installation co-located with a Department of Defense Education Activity (DoDEA) school, to include facilities, access, capacity, fees, transportation, and wrap around care through an in-depth program analysis.

- Identify options for revising the current opportunities for family members OCONUS to access high-quality preschool, in order to achieve optimum benefit for children.
- Identify the most efficacious models and the associated costs required to implement a quality universal preschool program at each targeted OCONUS installation.
- Produce a final research brief with accompanying executive summary and report, which contains all relevant data tables as well as a gap analysis of recommendations installation by installation or grouped installations with similar characteristics such as demographics and logistics.

### **C. Program Area Description**

USDA/NIFA and the DoDEA seek to assess the preschool program availability to military families located at OCONUS installations worldwide.

#### **Current Status of Preschool Program Availability to Military Families OCONUS**

Several states with high populations of military Service members, including Georgia and Florida, now provide universal preschool for all 4 year olds. Military families stationed OCONUS desire access to preschool opportunities for their children, but these opportunities are not universally available.

While DoDEA provides universal half day preschool to all dependents residing on military installations within the continental United States (CONUS) that have DoDEA schools, DoDEA does not provide universal preschool to dependents residing OCONUS in Europe or the Pacific.

OCONUS DoDEA operates a Sure Start program, which targets children whose parent has a military rank of E1-E5, and a Preschool Services for Children with Disabilities (PSCD) program exclusive to children with a diagnosed disability. These programs are provided at no cost to the family. Each Military Service operates Child Development Centers (CDC) which provides a full day care program with an embedded Preschool. Some CDCs offer a part-day preschool program with no wrap around care. The CDCs charge fees for these programs based on a total family income calculation, and there are differences among programs based on the individual Service and installation.

Families living overseas who do not qualify for DoDEA's preschool programs or for whom programs or space in the CDC is not available must obtain private services or provide homeschool services. This current system does not universally provide equal access and consistent quality to military families.

## **PART II—AWARD INFORMATION**

### **A. Available Funding**

The amount available for NIFA support of this program in **FY 2014** is approximately **\$315,000**. The successful applicant will be invited to enter into a cooperative agreement with NIFA. Elsewhere in this RFA the term ‘grant’ includes cooperative agreement

Awards issued as a result of this RFA will have designated the Automated Standard Applications for Payment System (ASAP), operated by the Department of Treasury’s Financial Management Service, as the payment system for funds. ### **B. Types of Applications**

In FY 2014, applications may be submitted as — “NEW” applications only. All new applications will be reviewed competitively using the selection process and evaluation criteria described in Part V—Application Review Requirements.

**(1) New application.** This is a project application that has not been previously submitted to the PAFS Program. We will review all new applications competitively using the selection process and evaluation criteria described in Part V—Application Review Requirements.

### **C. Project Types**

For FY 2014, approximately **\$315,000** will be available to fund one proposal for one year. The statutory time limitation for awards issued under this authority is five years. No award may exceed this statutory time limitation.

### **D. Responsible and Ethical Conduct of Research**

The responsible and ethical conduct of research (RCR) is critical for excellence, as well as public trust, in science and engineering. Consequently, we consider education in RCR essential to the preparation of future scientists. In accordance with sections 2, 3, and 8 of 7 CFR Part 3022, institutions that conduct USDA-funded extramural research must foster an atmosphere conducive to research integrity, bear primary responsibility for prevention and detection of research misconduct, and maintain and effectively communicate and train their staff regarding policies and procedures. In the event an application to NIFA results in an award, the Authorized Representative (AR) assures, through acceptance of the award that the institution will comply with the above requirements. Per award terms and conditions, grant recipients shall, upon request, make available to NIFA the policies, procedures, and to support the conduct of the training.

Note that the training referred to herein shall be either on-campus or off-campus training. The general content of the ethics training will, at a minimum, emphasize three key areas of research

ethics: authorship and plagiarism, data and research integration, and reporting misconduct. Each institution will be responsible for developing its own training system, as schools will need flexibility to develop training tailored to their specific student needs. Grantees should consider the Collaborative Institutional Training Initiative (CITI) program for RCR (<https://www.citiprogram.org/rcrpage.asp>). Typically this RCR education addresses the topics of: Data Acquisition and Management - collection, accuracy, security, access; Authorship and Publication; Peer Review; Mentor/Trainee Responsibilities; Collaboration; Conflict of Interest; Research Misconduct; Human Subject Research; and Use of Animals in Research.

## **PART III—ELIGIBILITY INFORMATION**

### **A. Eligible Applicants**

Applications may be submitted by State agricultural experiment stations, State cooperative extension services, all colleges and universities, other research or educational institution or organization, and any other contractor or recipient, either foreign or domestic, to further research, extension, or teaching programs in the food and agricultural sciences of the Department of Agriculture.

Award recipients may subcontract to organizations not eligible to apply provided such organizations are necessary for the conduct of the project.

### **B. Cost Sharing or Matching**

NIFA does not require matching support for this program and matching resources will not be factored into the review process as evaluation criteria.



## **PART IV—APPLICATION AND SUBMISSION INFORMATION**

### **A. Electronic Application Package**

**Section 2: Statement of Need**

- Describe how this overall project will address the issues and the audience to be served.

### **Section 3: Objectives**

Clear, concise, and logically presented statement(s) of specific aims of the proposal.

### **Section 4: Methods**

The procedures or methodology to be applied to the proposed effort should be described. This section should include, but not necessarily be limited to:

- Methods to be employed; including the rationale for their use in the project;
- Development and/or implementation challenges that may be encountered;
- Limitations to proposed procedures; and
- Describe stakeholder involvement and collaborations in problem identification, planning, implementation, and evaluation.

### **Section 5: Evaluation Design and Methodologies**

The primary responsibility will be to assess the availability of preschool programs at OCONUS installations utilizing multiple sources of data, feedback, and information and synthesize findings in a final report that will inform future directions for planning preschool access among military families.

#### **D. Funding Restrictions**

Agency policy limits the maximum potential funding period (including any awards transferred from another institution or organization) to five years in duration. The funding period will commence on the effective date cited in the award instrument. Any such limitation also applies to subcontracts made under awards subject to a funding period limitation.

The PD may incur pre-award costs within the 90-day period immediately preceding the effective date of the award providing: the approval of pre-award spending is made and documented in accordance with the awardee's normal procedures prior to the incurrence of the cost(s); the advanced funding is necessary for the effective and economical conduct of the project; and the costs are otherwise allowable. Pre-award expenditures are made at the awardee's risk. AOR authority to approve pre-award costs does not impose an obligation on NIFA: (1) in the absence of appropriations; (2) if an award is subsequently not made; or (3) if an award is made for a lesser amount than the awardee expected.

Pre-award costs incurred outside the 90-day period immediately preceding the effective date of the award must receive written approval from the ADO. Please verify with the Administrative/Business Contact listed in this RFA before any pre-award expenditures. Any expenditures made before then are at your own risk.

## **PART V—APPLICATION REVIEW REQUIREMENTS**

### **A. General**

We evaluate each application in a 2-part process. First, we screen each application to ensure that it meets the administrative requirements as set forth in this RFA. Second, a review panel will technically evaluate applications that meet these requirements.

We select reviewers based upon their training and experience in relevant scientific, extension, or education fields, taking into account the following factors: (a) The level of relevant formal scientific, technical education, or extension experience of the individual, as well as the extent to which an individual is engaged in relevant research, education, or extension activities; (b) the need to include as reviewers experts from various areas of specialization within relevant scientific, education, or extension fields; (c) the need to include as reviewers other experts (e.g., producers, range or forest managers/operators, and consumers) who can assess relevance of the applications to targeted audiences and to program needs; (d) the need to include as reviewers experts from a variety of organizational types (e.g., colleges, universities, industry, state and federal agencies, and private profit and non-profit organizations) and geographic locations; (e) the need to maintain a balanced composition of reviewers with regard to minority and female representation and an equitable age distribution; and (f) the need to include reviewers who can judge the effective usefulness to producers and the general public of each application.

### **B. Evaluation Criteria**

The evaluation criteria below will be used to review applications submitted in response to this RFA:

#### **1. Potential for Assessing Access to Preschool Programs OCONUS.**

This criterion is used to assess the likelihood that the project will succeed in 1) meeting established objectives in delivering a comprehensive report to inform DoD Leadership on future directions for preschool access OCONUS based on an extensive literature review and findings from this in-depth analysis, (2) providing the overall management of this study including collaborations, partnerships, and project staff, and 3) demonstrating successful past experience with related projects, particularly those involving early care and education (ECE), ECE program administration and evaluation, systems of care, and military families with young children including the work and related work of key project personnel.

#### **2. Proposed Approach and Program Coordination**

This criterion is used to assess the soundness of the proposed approach including statement of need, scope of the project, objectives, methodology, key personnel, timeline, expected products and results and communication plan. Recent experience working with military components in partnership with Land-grant Universities and the Cooperative Extension Service is preferred. Also cite any experience in conducting research related to program assessment and evaluation in coordination with military components.

### **3. Evaluation**

This criterion is used to assess the adequacy of the evaluation design and its capacity to measure the extent to which program objectives are met and build upon any outcomes to date.

### **4. Budget and Budget Narrative**

This criterion is used to assess the extent to which the total budget adequately supports the project and is cost effective based on budget outline provided. Elements considered include: the necessity and reasonableness of costs to carry out project activities and achieve project objective and the adequacy of time committed to the project by key project personnel.

### **C. Conflicts of Interest and Confidentiality**

During the peer evaluation process, we take extreme care to prevent any actual or perceived conflicts of interest that may impact review or evaluation. Names of submitting institutions and individuals, as well as application content and peer evaluations, are kept confidential, except to those involved in the review process, to the extent permitted by law. In addition, the identities of peer reviewers will remain confidential throughout the entire review process, to the extent permitted by law; therefore, the names of the reviewers will not be released to applicants.

### **D. Organizational Management Information**

Specific management information relating to an applicant shall be submitted on a one time basis, with updates on an as needed basis. This requirement is part of the responsibility determination prior to the award of a grant identified under this RFA, if such information has not been provided previously under this or another NIFA program. We will provide you copies of forms recommended for use in fulfilling these requirements as part of the preaward process. Although an applicant may be eligible based on its status as one of these entities, there are factors that may exclude an applicant from receiving federal financial and nonfinancial assistance and benefits under this program (e.g., debarment or suspension of an individual involved or a determination that an applicant is not responsible based on submitted organizational management information).



## **PART VI—AWARD ADMINISTRATION**

### **A. General**

Within the limit of funds available for such purpose, the NIFA awarding official shall make grants to those responsible, eligible applicants whose applications are judged most meritorious under the procedures set forth in this RFA. The date specified by the NIFA awarding official as the effective date of the grant shall be no later than September 30 of the federal fiscal year in which the project is approved for support and funds are appropriated for such purpose, unless otherwise permitted by law. The project need not be initiated on the grant effective date, but as soon thereafter as practical so that project goals may be attained within the funded project period. All funds granted by NIFA under this RFA may be used only for the purpose for which they are granted in accordance with the approved application and budget, regulations, terms and conditions of the award, applicable federal cost principles, USDA assistance regulations (parts 3015 and 3019 of 7 CFR), and NIFA General Awards Administration Provisions at 7 CFR part 3430, subparts A through E.

### **B. Award Notice**

The award document will provide pertinent instructions and information including, at a minimum:

- (1) Legal name and address of performing organization or institution to whom the director has issued an award under the terms of this request for applications;
- (2) Title of project;
- (3) Name(s) and institution(s) of PDs chosen to direct and control approved activities;
- (4) Identifying award number assigned by NIFA;
- (5) Project period, specifying the amount of time NIFA intends to support the project without requiring recompetition for funds;
- (6) Total amount of financial assistance approved for the award;
- (7) Legal authority(ies) under which the award is issued;
- (8) Appropriate Catalog of Federal Domestic Assistance (CFDA) number;
- (9) Applicable award terms and conditions (see <http://www.nifa.usda.gov/business/awards/awardterms.html> to view NIFA award terms and conditions);

(10) Approved budget plan for categorizing allocable project funds to accomplish the stated purpose of the award; and

(11) Other information or provisions deemed necessary by NIFA to carry out its respective awarding activities or to accomplish the purpose of a particular award.

## **PART VIII—OTHER INFORMATION**

### **A. Access to Review Information**

### **B. Use of Funds; Changes**

#### **1. Delegation of Fiscal Responsibility**

Unless the terms and conditions of the award state otherwise, awardees may not in whole or in part delegate or transfer to another person, institution, or organization the responsibility for use or expenditure of award funds.

#### **2. Changes in Project Plans**

a. The permissible changes by the awardee, PD(s), or other key project personnel in the approved project shall be limited to changes in methodology, techniques, or other similar aspects of the project to expedite achievement of the project's approved goals. If the awardee or the PD(s) is uncertain as to whether a change complies with this provision, the question must be referred to the Authorized Departmental Officer (ADO) for a final determination. The ADO is the signatory of the award document, not the program contact.

b. The awardee must request, and the ADO must approve in writing, all changes in approved goals or objectives prior to effecting such changes. In no event shall requests be approved for changes that are outside the scope of the original approved project.

c. The awardee must request, and the ADO must approve in writing, all changes in approved project leadership or the replacement or reassignment of other key project personnel, prior to effecting such changes.

d. The awardee must request, and the ADO must approve in writing, all transfers of actual performance of the substantive programmatic work in whole or in part and provisions for payment of funds, whether or not federal funds are involved, prior to instituting such transfers, unless prescribed otherwise in the terms and conditions of the award.

e. The project period may be extended without additional financial support, for such additional period(s) necessary to complete or fulfill the purposes of an approved project, but in no case shall the total project period exceed any applicable statutory limit or expiring appropriation limitation. The terms and conditions of award include information about no-cost extensions of the award and when ADO's prior approval is necessary.

f. Changes in Approved Budget: Unless stated otherwise in the terms and conditions of award, changes in an approved budget must be requested by the awardee and approved in writing by the

ADO prior to instituting such changes, if the revision will involve transfers or expenditures of amounts requiring prior approval as set forth in the applicable Federal cost principles, Departmental regulations, or award.

### **C. Confidential Aspects of Applications and Awards**

When an application results in an award, it becomes a part of the record of NIFA transactions, available to the public upon specific request. Information that the Secretary determines to be of a confidential, privileged, or proprietary nature will be held in confidence to the extent permitted by law. Therefore, any information that the applicant wishes to have considered as confidential, privileged, or proprietary should be clearly marked within the application. The original copy of an application that does not result in an award will be retained by the Agency for a period of three years. Other copies will be destroyed. Such an application will be released only with the consent of the applicant or to the extent required by law. An application may be withdrawn at any time prior to the final action thereon.
